Furthermore, when registering and signing this Membership Form, the Member acknowledges and agrees to all the terms and conditions set out in the Code of Conduct of HOG (including, for the avoidance of doubt, any By-Laws duly adopted by the members for general application) – and the Member whose application for membership has been accepted shall be bound by it, or which subsequently may be altered or amended and in force at any future time. No person shall be absolved from the effect and application of the Code of Conduct by reason of the fact that he may not have received a copy thereof. I further recognize that while the Chapter is chartered with H.O.G., it remains a separate, independent entity solely responsible for its actions, subject to the Indemnity/Waiver of liability below. The Member acknowledges and consents to his/her personal information being processed as envisaged in the Protection of Personal Information Act, No 4 of 2013 ('POPI') for the Purpose of the Chapter as contained in the Code of Conduct including, without limitation, communication with its Members from time, which the Chapter shall be entitled to do unless a Member specifically objects thereto as provided for in section 10 of POPI.

THIS IS A RELEASE – INDEMNITY/WAIVER OF LIABILITY by the Member participating or involved in whatever capacity in any event and activity conducted by HOG ("Event"), and when signing this Membership Form and become a Member, by doing so:

1. I fully acknowledge and understand the risks and dangers inherent in motorcycling, acknowledge that I have chosen out of my own free will without any undue influence to voluntarily participate in the Event and expressly agree to assume the entire risk of my participation therein;
2. I hereby release, indemnify and hold harmless the HARLEY OWNERS GROUP, Harley-Davidson, Inc., Harley-Davidson Motor Company, Harley-Davidson Europe, Ltd, and any of its corporate affiliates as well as the Harley-Davidson Sponsoring Dealer in relation to an Event, and the Cape Town Chapter itself as well as the afore-mentioned Sponsoring Dealer and respective officers and directors of Cape Town Chapter itself, participating in an Event (all hereinafter jointly and severally referred to as the "Released Parties") from:
 - 2.1 any claims or suits which I have or may later have relating to my person (including paralysis or death) and/or property or any costs incurred or damages suffered by me, whether or not such claims suits, costs or damages result from negligence (except gross negligence and wilful intent) on the part of any or all of the Released Parties arising from, or in connection with, my participation in whatever capacity in the Event, and I assume all risks of injury and damage to my person and property arising, directly or indirectly, from the conduct of the Event; or
 - 2.2 any act or omission arising from, or in connection with, the conditions, qualifications, instructions, rules or procedures under which the Event is conducted by anyone of the Released Parties; or
 - 2.3 Any criminal or civil liability imposed upon a Released party arising, directly or indirectly, from any act or omission by me.
3. I UNDERSTAND THAT THE ABOVE MEANS THAT I AGREE TO SUE THE "RELEASED PARTIES" FOR ANY INJURY OR RESULTING DAMAGE TO MY PERSON OR PROPERTY ARISING FROM, OR IN CONNECTION WITH, THE PERFORMANCE OF ANY EVENT IN WHATEVER CAPACITY.

H.O.G. CAPE TOWN CHAPTER: CODE OF CONDUCT

PURPOSE: H.O.G. Chapter Cape Town shall function in a structured form and manner as a non-profit volunteer organisation, affiliated to the Harley Owner Group ('H.O.G.') with the purpose to ensuring that all members shall participate in motorcycling activities by promoting orderly, efficient, responsible safe riding of Harley-Davidson motorcycles and also conducting social and charitable activities and encouraging participation therein – all such activities shall be conducted in an amicable and transparent manner consistent with a family-oriented, non-political and non-sexist philosophy and to provide a welcoming, friendly, safe and respectful environment for all its members, guests and general public.

CONDUCT: This Chapter through its members shall do their utmost to advance its Purpose to the fullest extent possible, and to this end, all members shall at all times:

- First and foremost, treat all fellow members of H.O.G. with dignity and respect in a cordial and friendly attitude and approach, and at all times avoiding offensive conduct and behaviour, including of a sexual, racial or religious nature or any verbal and physical abuse, discrimination or harassment, and rather strive to create general harmony amongst members and having fun together.
- Adopt generally accepted safe and responsible riding techniques and abide by road laws and traffic legislation (including having the requisite drivers licence) as well as the instructions from Road Captains and marshals of HOG
- Refrain from making any public statements (including postings on social media) not conducive to the principles enshrined in this Code of Conduct and HOG in general.
- Act in a manner that does not disparage HOG and its members specifically but in the broader context also Cape Town HOG Chapter, as well as any other HOG Chapter and its members or a sponsoring Harley-Davidson Dealership or intend to bring their good name and reputation into disrepute, irrespective of circumstances.
- Procure that his/her guests adhere to the principles enshrined in this Code of Conduct.
- Ensure that he/she remains a "member in good standing", i.e. both international HOG membership fees and local Chapter membership fees must be paid up in full and he/she must have an active ZA number and no disciplinary proceedings must be pending against such member.
- Respect and adhere to the directives of HOG issued from time within the framework of this Code of Conduct and furthermore any By-Laws duly adopted by the members of HOG for general application.
- Abide by the Annual Charter for H.O.G. Chapters and, on the specific understanding that for as long as H.O.G. Cape Town is sponsored by Cape Town Harley-Davidson Dealership, the functioning and activities of H.O.G. shall be conducted in consultation with such Dealership
- Respect the protection rendered in respect of the trademarks, logo's and licences towards H.O.G., HARLEY OWNERS GROUP, LOH, LADIES OF HARLEY, Logo's and Trademarks bearing the Harley-Davidson name, bar and shield and colours as registered and under license to the Harley-Davidson Motor Company.

SANCTION: It is impossible to outline all possible generally accepted standards of behaviour in the Code of conduct and common sense and individual circumstances all apply when determining appropriate behaviour. Accordingly, the principles enshrined above and such general standards of behaviour will be considered when violations or infractions need to be evaluated for the better of H.O.G. to be conducted as and when deemed necessary and in the manner they deem appropriate by the elected Office Bearer of H.O.G. and, if applicable, the Dealer Principal or appointed liaison of the sponsoring Harley-Davidson Dealership – the applicable sanction shall be in their reasonable discretion (including, suspension and expulsion in severe cases).
